On 5/19/20, I was contacted as an on call violent crime investigator to respond to the Super China Buffet at 2698 N. Monroe St. to assist with investigating an officer involved shooting. I arrived at the scene and met with investigators and supervisors to gather information regarding known information at the time. Once I understood the area where the incident took place, I was directed to a white male seated on a bus stop bench on the east side of the road in front of the Circle K at 2683 N. Monroe St. I made contact with that witness who identified himself as Steve Fairbanks. He recounted what he saw and heard regarding this incident. Fairbanks advised he was seated on the same bench when he heard a verbal altercation across the street at the Super China Buffet. He heard yelling and screaming and it was coming from the middle area of the Super China Buffet (this is the area around the front door and under the overhang). He saw shadows moving and could not identify people. When asked how many people there were he told me "more than one". He saw two males walk from the China Buffet over to the Circle K and one of the males was saying that someone had just tried to poke his eyes out and he was blind. He said this over and over. That male was older with a white beard. Fairbanks would only say the other person who was escorting the injured man was also a male. The injured male was bleeding from his face and a cut on his forearm. Once in the Circle K parking lot, the unknown male (escorting the victim) walked away and another male approached the victim and some people tried to help him. The unknown male escorting the victim did come back but then walked away south bound before police arrived. The staff at the Circle K was aware of the situation also and had told the victim to just wait there. Fairbanks tried to stay out of the entire incident. Eventually law enforcement arrived and Fairbanks was walking away (south bound) past the Econo Lodge when he heard several gun shots coming from north of his location. He advised it was loud and the gunshots echoed. He saw people scrambling and then saw police lights. Fairbanks did make it clear he could provide better descriptions of people and the situation but was choosing not to so he would not be branded a "snitch". He did not provide a description of the other involved party across the street and said he just saw "shadows" and there may have also been an animal.

I spoke with Deanna O'Neal next. O'Neal advised she knows the victim Richard Haines but she calls him Jack. She advised she and her boyfriend James Grant were walking south on N. Monroe St. from the La Casa Inn Hotel at 2801 N. Monroe St. They stopped at the Super China Buffet as O'Neal saw her friend Haines. Haines was hanging around with a white male she did not know and the men were drinking beers. The unknown male was rude and belligerent and made a comment about wanting to have sex with her. He also had a dog with him. O'Neal and her boyfriend would walk on to the Dollar General (believed to be 2525 N. Monroe St.). While at the store, Grant purchased some dog food for the male's dog. They walked back north toward the La Casa Inn and stopped again at the Super China Buffet. This was around 7:20pm or 7:30pm. O'Neal spoke with Haines and Grant briefly made contact with the male. Once O'Neal and Grant walked away, Grant told O'Neal that the unknown male pulled a knife on him. O'Neal did not see the incident and only heard about it from Grant. The two went to the hotel and only came down to the scene when they heard there had

been a shooting and O'Neal wanted to find out if the victim was Haines.

I spoke with Grant next (I would interview him at the scene and again at his hotel room at the La Casa Inn later that morning). Grant is deaf (or mostly deaf) and reads lips to communicate. Grant gave a similar account as O'Neal but with some additional information regarding the interaction he had with the suspect. He verified that they did walk by Haines and the suspect one time and then returned after going to the store. He said he did not know either man but knew O'Neal was friends with Haines. After he bought some food for the suspect's dog he approached and gave the suspect the food. The suspect pulled out a knife and was using it to open the can of food. The suspect was talking to Grant but he could not understand him because he had a cigarette in his mouth so he could not read his lips correctly. Grant was trying to tell him that he could not understand him and he leaned in to try and understand the suspect and the suspect drew another knife from his side and now held two knives in Grant's direction. Again, Grant could not understand what the suspect was saying to him but could tell the suspect was not being friendly at this point. Grant backed away and walked off with O'Neal. When asked, Grant told me he believed that the suspect felt threatened by Grant because he leaned in towards him. He felt the suspect's actions were defensive and not that he was about to be stabbed. Grant could only provide a vague description of the suspect but did know he was the white male with the short beard and the black dog. He described Jack as having a longer beard. He also knew the knives were big. He also said a black bald headed male was with the men when they first contacted them but he was gone the second time and now a younger white male was with them.

I next interviewed a white male who had walked up with Haines' phone. O'Neal had told me that someone had Haines' phone and she wanted to make sure he got it back. The male was identified as Casey Durrance. Durrance advised he is friends with Haines and has been friends with him for about a month and half. Today he met up with Haines across from the Super China Buffet around 5:30pm or 6:00pm. Haines wanted Durrance to come hang out at the Super China Buffet with the suspect who had bought some pizzas. Durrance agreed to go. The three men hung out together for hours in front of the doors (under the overhang) of the China Buffet. Haines had several beers but the suspect drank many beers and Durrance advised the suspect became more belligerent as the night went on. At one point the suspect tried to slap Durrance and Haines had to step in. Haines told the suspect that Durrance did not do anything to him and the issue got settled. Haines explained to Durrance that the suspect tried to slap Durrance, the was talking to his ex-wife. Durrance said that at times the suspect seemed to be talking to someone who was not there. About two hours after the suspect tried to slap Durrance, the suspect began saying hostile things to Haines. The suspect. Durrance did not understand why the suspect got so mad. Haines realized that the suspect was talking to him and not an imaginary person. Haines told the suspect that

they had been dealing with the suspect's offensive behavior and with him thinking they were talking about him and he has been getting violent and aggressive and he was not going to take it anymore. The suspect asked what Haines was going to do about it. Haines told the suspect he was not trying to fight but the suspect then initiated an unprovoked physical attack on Haines. The suspect punched Haines in the face/head several times and tackled him to the ground. The suspect got on top of Haines and was sticking his thumbs in Haines' eyes and was trying to gouge them out. Haines was yelling for the suspect to stop. Durrance stood by but did not want to get involved and was going to let the men fight it out. He advised he told the suspect to stop gouging Haines' eyes out because it was not fair and was about to separate the men when Haines was able to roll the suspect off of him and get up while delivering a couple punches to the suspect to separate them and get away. Durrance got between the two men and told the suspect that the fight was over. The suspect walked away. He advised Haines was injured and could not see well from the eye gouges, so he walked with him across the street to the Circle K to assist him. Durrance did not want to go onto the Circle K property because he is trespassed from the business. Durrance walked back across the street to get some of Haines' property (bag, wallet, phone). Durrance did not see the suspect when he walked over the first time. He did see a fixed blade knife with a black handle on the ground near where the two men fought (under the overhang in front of the front door to the restaurant). He picked up the knife and put it on a pylon holding up the overhang. Durrance brought the bag, hat, and wallet back and set it down on the edge of the Circle K property. Durrance did make sure that Haines got into the Circle K and was getting the help he needed since he was injured. Durrance walked back across the street a second time to look for Haines' cell phone. This time, the suspect appeared from around the northeast corner of the restaurant. The suspect had a knife in his hand and told Durrance he was lying to him. Durrance told the suspect he was not Haines and to stay away but the suspect kept calling him a "bitch" and approaching him with the knife while saying he was going to "get him". The suspect was pointing the knife at Durrance and Durrance believed that the suspect had the ability, means, and intent to stab him and felt his life was being threatened. He advised they made eye contact. Durrance did tell the suspect to put the knife down and they could fight fair but the suspect kept the knife and approached Durrance. He advised the suspect got around 10 feet from him. Durrance continued to retreat and went back across the street and started walking south on N. Monroe St. He had found Haines' cell phone and had it on his person. After walking past the Red Lobster he heard several gun shots. He was not sure who had been shot and did not know if it was Haines. Durrance walked over to the Whataburger on N. Monroe St. and stood around until he got a call from O'Neal and she told him Haines had not been shot. Durrance then decided to walk up to the scene. He gave Haines' phone to O'Neal. I would request Ofc. White get the phone from O'Neal (I had told her we would get Haines' properly to him) and she handed it over. Durrance would provide a description of the suspect and advised he has seen the suspect around but did not know him till this night. He also viewed a lineup shown to him by Inv. Isaacs and chose Wilbon Woodard (the deceased) as the person who attacked Haines and pulled a knife on him. Of note, Durrance did mention a black female said the suspect pulled a knife on her earlier in the night also. I saw the female around the scene earlier in the investigation but did not know where she went. Durrance did

not know her name but knew her to be homeless.

Most of my interactions with witnesses was captured by my body worn camera.

I went to the incident scene when the sun had risen and searched the area for places where bullets may have struck and any evidence still on scene. The scene had been cordoned off with crime scene tape and had been maintained by police officers. Investigators Isaacs and Ray assisted with the search and so did Forensic Technician Henderson. Several areas of possible bullet strikes were found and then photographed by Henderson. These strikes were on the north facing front wall of Super China Buffet near the northeast corner and on the western wall of the neighboring unnamed hotel being renovated. Henderson also found other potential evidence to include a cell phone and knife on the north side of the Super China Buffet. This would be documented by him.

On 5/19/20, I responded as one of the on-call Investigators to the China Super Buffet in reference to an Officer involved shooting. I arrived on scene and was tasked with canvassing for surveillance video. I noted exterior cameras at Denny's located at 2690 N Monroe Street, China Super Buffet located at 2698 N Monroe Street, Circle K located at 2683 N Monroe Street, and North Florida Animal Hospital located at 2701 N Monroe Street.

Denny's and Super China Buffet were closed during my presence. I spoke with the nightshift clerks at Circle K. The clerks advised they did not have access to the surveillance system, but a manager would be in at 8:00am that morning. I contacted a vet tech at North Florida Animal Hospital. The tech advised he did not have access to the surveillance system, but he would make notifications to the owners in the morning.

I completed canvassing all surround buildings and was tasked with creating a photographic lineup once the identity of the deceased was. I received notification from Sgt. Butler of the deceased name, Woodard Cleveland Wilbon. Wilbon did not have any CJIS history thus I used his DAVID photograph. I then selected five random white males between the ages of 65-75 with the last name of Smith. I completed two photographic line up packets and responded to the incident scene. I provided Inv. Isaacs with the photographic lineup one at a time and retrieved them back after she had completed the process. I impounded the lineups under TPD 2020-CA-1011

I returned to the incident scene later in the morning to review surveillance video from the neighboring businesses. I made contact with Circle K manager, Patrice Richardson, at the store. Richardson allowed me access to the system. I reviewed the surveillance footage and noted the following.

Victim Haines is observed crossing N Monroe Street from China Super Buffet towards Circle K with the assistance of an unknown white male. Haines walks to the parking requesting help. There was a store clerk in the parking lot sweeping at the time Haines requested help. The clerk dialed 911 and requested assistance. Video shows and DeGraw arriving on scene along with Leon County Emergency Medical Services. LCEMS tends to Haines as drives his patrol vehicle to the China Super Buffet and parks under the awning with his headlights on. Video shows using his flashlight and then a stream of emergency vehicles approaching. I exported the video to a hard drive and departed.

I made contacted with staff at North Florida Animal Hospital. I reviewed their footage from the north door camera. The quality of the footage was poor and had the same angel as Circle K. I did not collect the video footage due to the poor quality and unable to see any relevant to the incident.

I proceeded to the Denny's, which is just south of the incident location. I reviewed their live stream of the exterior camera. A large tree was blocking the view of the incident location, thus I did not review the footage from the incident.

I returned to the station and burned the Circle K footage to a DVD. The DVD was impounded as evidence

under TPD case number 20-78840.

I contacted the owner of China Super Buffet. I was advised the business does have exterior cameras, but the business had been closed since March 17, 2020 due to COVID-19. I expressed the importance to view the surveillance cameras due to the incident being captured on their cameras. I was told they would review the surveillance cameras as soon as possible. Follow up will continue to review the China Super Buffet cameras.

This concludes my involvement in this case.

On May 19, 2020, I was asked to assist with this investigation. I responded to the scene and made contact with other Investigators. Investigator Warren asked me to present the two victims, Casey Durrance and Richard Haines, with photographic lineups.

Investigator Sullivan provided me with the first lineup, and I made contact with Durrance in the Denny's parking lot. I read Durrance the photographic lineup instructions from the department issued form and provided him with a copy. Durrance advised he understood the instructions and did not have any questions. I presented the lineup to Durrance, one photograph at a time, and he selected image number two as the suspect in this case. When he saw image number two, Durrance said, "That's him right there." Durrance then took the image to a more brightly lit area and observed the image again. Durrance then confirmed the pictured individual was the suspect from this case and commented, "No doubt in my mind." My interaction with Durrance was captured on my body worn camera.

I then obtained a new lineup from Investigator Sullivan and made contact with Haines in the Circle K parking lot. Haines' eyes had been injured during this incident and he advised he was having trouble seeing clearly. Despite that, Haines said he wanted to review the photographic lineup. I read Haines the photographic lineup instructions from the department issued form and provided him with a copy. Haines advised he understood the instructions and did not have any questions. I presented the lineup to Haines, one photograph at a time, and he was unable to make an identification. However, Haines did ask if he would be able to review the lineup again when his eyes healed. My interaction with Haines was captured on my body worn camera.

I was later advised by other Investigators that the photograph Durrance selected was an image of the suspect, Wilbon Woodard.

This concluded my involvement in this case.

On 05/19/2020 I responded to the Circle K gas station located at 2683 North Monroe Street in reference to a possible battery. When I arrived on scene, I made contact with victim Richard Haines in the parking lot. Richard was pointed towards me by a black male who later walked away from the scene.

As Richard approached, I observed him to have blood on his knees, elbows, and around his eyes. I called for EMS and called for another unit over my radio.^{2020-CA-1011} advised he would be in route.

Richard advised the following: Richard and the suspect who he only knows as "William" had been drinking and hanging out at the China Super Buffet located at 2683 North Monroe Street. Note: Due to Richard only knowing the suspect as "William" I will use this name every time I talk about the suspect. Richard observed "William" wearing two knives on his hips which he advised are like hunting knives that do not fold. Richard observed "William" pull his knife and threaten others. Richard did not provide any information as to who was threatened by "William". Richard advised at one point "William" pulled his knife and threatened him stating, "Ill cut you, I'll kill you". Richard confronted "William" about pulling his knife which started a fight between them. Richard advised he received his cuts on his elbows and knees from fighting on the ground. Richard was having a hard time seeing and advised "William" used "Williams" fingers in an attempt to gouge his eyes out. I asked Richard where the knives were while he was trying to gouge his eyes. Richard advised they were still in the sheath and he was using both hands to gouge his eyes. I asked Richard if he attempted to use the knives on him and he advised no. Richard pointed at a black male who he advised witnessed everything. Richard pointed at the black male and asked him to come over to where we were standing. The black male turned and walked away from my location without providing any information. Richard described the suspect as a white male wearing a unknown color t-shirt, unknown colored long pants, a crew cut haircut, and had a small black chihuahua with him.

Ems arrived on scene and Richard walked into the ambulance. As Richard entered the ambulance, I noticed ^{2020-CA-1011} had contact with a subject across the street. Due to the incident please see TPD case 2020-78840 for further information.

My interactions were captured on my BWC.

This concludes my involvement in this case.

At 02:48 am on Tuesday, May 19, 2020, Officer Hanbury #385 and I responded to Tallahassee Memorial Hospital (TMH) to follow up with the victim of an aggravated battery at 2698 North Monroe Street.

I met with the victim, Richard Haines in emergency room #30. He had bleeding wounds on both hands, upper right arm, and both knees. Haines was barely able to open his eyes and had cuts and scrapes around his eyes. I photographed the injuries and uploaded them to Evidence.com.

Haines was transported to TMH from Circle K at 2683 North Monroe Street by MED 26, Jason Stark, and Sanwal Ahmed (RUN# EM-20-0016974).

Haines reported the following: He met the suspect earlier in the day of 05/18/2020. Haines and the suspect were hanging out under the shelter in front of the China Super Buffet at 2698 North Monroe Street. Haines believed the suspect's name was William. He described the suspect as a white male approximately 71 years old with two "hunting" knives concealed in sheaths on his hip. Haines said throughout the day, William threatened multiple people, including an unknown black male with the knife the suspect had on his hip. Haines confronted William at the China Super Buffet in reference to the threats. William and Haines began fighting on the ground when William pressed his thumbs into Haines' eyes. Afraid that William would use the knives in the fight, Haines held on to the sheaths so that William was unable to retrieve them. He said the knives were not involved in the fight. Haines managed to disengage from the fight and went across the street to the Circle K where employees called 911.

Investigator S. Bennett questioned Haines at the hospital. See her supplement.

Forensic Technician K. Stevens photographed Haines' injuries and collected his clothing for processing.

Once Haines was discharged from the hospital, I searched his person and transported him back to 2683 North Monroe Street. Haines was provided a copy of Marsy's Law with the case number and a Victim's Rights Brochure. Due to his injuries, Haines was unable to provide a sworn written statement. However, his statement was captured on my body-worn camera.

This contact with citizen(s) was captured on my body-worn camera (BWC). The footage was submitted per policy. Any discrepancies between this report and the video footage are unintentional. My reports are written to the best of my ability from my memory and the way that I perceived the events depicted.

On May 19th, 2020, I was contacted to respond to the Tallahassee Memorial Hospital to make contact with a victim of an aggravated battery. Upon arrival on scene, I made contact with victim, Richard D. Haynes in ER room #30. Haynes had blood covering his knees, hands, arms and appeared to have been involved in an altercation. Haynes' eyes appeared irritated and the sclera of his eyes were red.

Haynes stated he had been hanging out all day at the incident location with the suspect he knows as "William." Haynes stated the suspect would threaten people who were walking by with the sheath knives he had on his waist. Haynes stated he tried to calm the suspect down and stop him from continuing to threaten people when the suspect attacked him. Haynes stated the suspect grabbed him and they fell to the ground and began wrestling when the suspect forcefully inserted his thumbs into his (Haynes) eyes. Haynes stated the suspect tried to grab for his knife on his waist in the sheath when he (Haynes) grabbed ahold of the sheath to prevent the suspect from retrieving the knives.

Haynes stated another unknown subject intervened and pulled the suspect off of him and he walked over to the Circle K located at 2683 N. Monroe Street, Tallahassee, Florida where he remained until LCEMS and patrol officers responded. Haynes stated his backpack, hat and wallet was brought to him at the Circle K by an unknown black male subject, but his phone (Metro LG) was left on scene. Haynes stated when officers arrived on scene, he directed the officer to the area where he last saw the suspect and asked to retrieve his cellular phone. Haynes stated after the officer walked over to the area, he heard the gunfire while inside the ambulance. Haynes stated he would be able to identify the suspect by photograph.

Forensics Specialist Kelsey Stevens #821 arrived to photograph the victim's injuries and collect his clothing as evidence in this case.
